Fezile Dabi District Municipality, Infrastructure unit is seeking to further recruit unemployed residents from Metsimaholo Local Municipality. Participants who took part in the previous EPWP project in the area are discouraged to apply in order to provide for an equal opportunity for other participants to take part in the EPWP programme in line with EPWP prescripts.

REQUIREMENTS:

- South African citizens older than 18 years of age with a valid ID.
- Must be a permanent resident of Metsimaholo Local Municipality, provide proof of residence / affidavit to confirm residence.
- Must be physically fit and disciplined to work with other team members on the maintenance and cleaning of culverts and storm water channels.
- Must have communication skills and the ability to execute duties in line with the programme as requested from the project leader.
- Must be willing to enter into a 4 months fixed term contract.
- Ability to work as a team and be able to follow instructions.

- Participants will be responsible for their own transport to and from the workplace.
- Candidates with disabilities that will still be able to do the required work and fit the above requirements are also encouraged to apply.

RESPONSIBILITIES

- Carry out tasks as assigned by the team leader on the maintenance and cleaning of culverts and storm water channels
- Ensure that all personal protective equipment is correctly used, well maintained and taken care off.
- Ensure that all tools, equipment and materials under his control is taken care of, well maintained and accounted for.
- Attend and participate in training programmes when required to.
- Assist with inventory checks where applicable.
